SEVENTEENTH ANNUAL REPORT

This Report covers the activities of the North Carolina Rate Bureau during the period from September 1, 1993 through August 31, 1994.

ORGANIZATION

The North Carolina Rate Bureau was established effective September 1, 1977, as mandated by the North Carolina General Assembly with the passage of House Bill 658 which was ratified on June 30, 1977, and which was later codified as Article 36, Chapter 58, General Statutes of North Carolina.

GOVERNING COMMITTEE

During the Sixteenth Annual Meeting held October 26, 1993, Harleysville Mutual Insurance Company, Nationwide Mutual Insurance Company, Royal Insurance Company of America and The Travelers Insurance Company were elected as members of the Governing Committee for three-year terms.

The Governing Committee met eight times during the year, including four telephone conferences. All state Insurance Company served during the year as Chairman of the Governing Committee. The Aetna Casualty and Surety Company served as Vice-Chairman.
