CIRCULAR LETTER TO ALL MEMBER COMPANIES

Re: 1995 Advisory Statistical Work Group Training Sessions

The Workers Compensation Insurance Organizations' Bureau Managers appointed the Advisory Statistical Work Group (ASWG) to review, update and standardize the unit report. The ASWG recommended implementation of an expanded unit statistical report, which added many new data elements and revised, restructured or eliminated many current data elements. The ASWG expanded formats represent significant and extensive changes to the unit statistical data and the reporting process.

To assist carriers during the implementation process, the Pennsylvania Compensation Rating Bureau is coordinating a series of ASWG Implementation Training Sessions to be held in Philadelphia on Thursday, March 23, 1995 and in Chicago on Wednesday, March 29, 1995.
