CIRCULAR LETTER TO ALL MEMBER COMPANIES

Summary:

This circular includes the in-force policy count ceded to the Facility as of October 1, 2025.

The attached two-page exhibit shows the count of ceded policies in-force as of October 1, 2025. The total in-force policy count is down 11.9% from October 1, 2024. “Non-fleet private passenger” policies were 12.1% lower than prior year while “other than non-fleet private passenger” policies decreased by 4.1%. Please note that groupings for NCRF membership are not identical to NAIC company groupings.
