As of October 1, 2023

The attached two-page exhibit shows the count of Facility policies in-force as of October 1, 2023.

The total in-force policy count is up 18.0% from October 1, 2022. Non-fleet private passenger policies were 18.5% higher than prior year while other than non-fleet private passenger policies decreased by 2.4%.
