#### **ELIGIBILITY SEARCH TOOL**



The Eligibility Search tool is available in our ManageAR system. The tool allows agencies real-time access to the eligibility status of

employers. An instructional video on how to use this tool is located <u>here.</u>

#### ASSIGNED RISK CARRIERS

The Bureau works with servicing carriers and direct assignment carriers to place applicants requesting coverage in the residual market. This year marks the last year of a three-year term for servicing carriers that started January 1, 2020. The Bureau recently completed the bid process for the next threeyear term that starts January 1, 2023, and determined that the servicing carriers will remain the same for the upcoming term. One assignment carrier. direct American Interstate, has elected to discontinue and will no longer be directly writing assigned risk policies effective January 1, 2023.

#### WORKERS COMPENSATION



The 2022 voluntary market loss cost filing requesting a 4.8% decrease was approved by the Commissioner of

Insurance, and the assigned risk rate filing was approved at a decrease of 0.8%, both effective April 1, 2023.

#### PROPERTY



On August 18, 2022, the Rate Bureau filed the 2022 Dwelling rate filing, as directed by the Governing Committee.

The Dwelling filing proposed a two-year implementation of the indication, with 19.6% in year one and 19.2% in year two. A hearing has been scheduled on this filing to begin on April 17, 2023.

On October 31, 2022 the Rate Bureau filed the 2022 Mobile Home rate filings with the Commissioner of Insurance, as directed by the Governing Committee. The Mobile Home (F) program proposes a two-year implementation with 31.5% in year one and 33.0% in year two. The Mobile Home © program proposes a two-year implementation with 23.2% in year one and 24.5% in year two. This filing remains outstanding with the Department of Insurance at this time.

#### **STAFF UPDATES**

Since our last update, we've made some personnel changes and added a few new faces to our team. Allison Smart was promoted to the position of Director, Workers Compensation Operations, and Joyce Robinson was promoted to Manager, Data Services. Alex Allen and Ryan Philipson joined our Data Services team as data consultants and most recently, Morgan Willhite was hired as Manager, Training & Operations.
