CIRCULAR LETTER TO ALL MEMBER COMPANIES

Re: 2024 IDC Data Calls

Each year, the North Carolina Rate Bureau, the North Carolina Reinsurance Facility and the North Carolina Insurance Guaranty Association issue special data calls to support our organizations. The data we collect is used across the organizations for assessments, expense allowances, and rate filings. This circular outlines the data calls, the due dates, and where to find additional support. In North Carolina, each data call uses the IDC (Insurance Data Collection) system to collect the data.

IDC Access via NCRB Webportal

On the NCRB Web Site (<u>http://www.ncrb.org</u>), click "Member Login" at the top of the page. The PORTAL LOGON page displays. Once logged in, the Member Portal allows you to choose Personal Lines/IDC to access the system.

Fine Procedures

Fines may be charged, according to the following procedures:

Annual Statement and Expense Experience

To encourage timely submission of this data, the NCRB Governing Committee has approved the implementation of a penalty fine for the late submission of these data calls. A penalty fine of \$100 per day will be imposed for late submissions. The \$100 per day fine is imposed for the Annual Statement, Insurance Expense Exhibit, and Expense Experience data calls. Member companies are urged to meet the requested due dates to avoid late penalty (submission) fines.

Commercial Auto Ceded Statistical

To encourage timely submission of this data, the NCRF Board of Governors has approved the implementation of a Penalty for Late Submission of Requested Data. A penalty of \$100 per day will be imposed for all late submissions. Member companies are urged to meet the requested due date to avoid the penalty for a late submission. For complete information on Commercial Auto Ceded Data Call fines please refer to the NCRF <u>Standard Practice Manual</u>. (Section 4, Chapter 4 Statistical Requirements, Page 4-1)

Overview – IDC Reporting for North Carolina – estimated length 1 hour

Ceded Commercial Auto - New Process - estimated length 1 hour

Starting in 2024, the statistical data for companies which cede Other Than Private Passenger Liability to the North Carolina Reinsurance Facility will be collected using North Carolina's Insurance Data Collection (IDC) Reporting Tool. This training will show how the process has changed from prior years, highlighting the new format – a text file upload. This training will also describe the fining process that governs this data call.

Target Audience: This training will be targeted at NCRF Carriers that cede Commercial Auto data. Any individuals that interact with the statistical data may find this beneficial. Other audiences may include compliance, actuaries, underwriters, statistical reporting professionals, finance and/or accounting, or IT professionals.
