CIRCULAR LETTER TO ALL MEMBER COMPANIES

Summary:

This circular provides 2024 ceded premium volume by company or group.

The Board of Governors has authorized the annual release of a report of written premium ceded to the Facility. This report compares total liability written premium in North Carolina by company or group and the ratio of ceded liability written premium to total written premium.

- Shown for each company (or group) is the total direct North Carolina automobile liability
 written premium reported for the year on Statutory Page 14 of the annual statement(s) for
 North Carolina and the written premium for ceded business from the Facility's accounting
 reports.
- Premiums for designated agent business ceded to the Facility have been excluded.
