CIRCULAR LETTER TO ALL MEMBER COMPANIES

Re: In-Force Policy Count
As of October 1, 2011

The attached two-page exhibit shows the count of Facility policies In-Force as of October 1, 2011.

Using an updated methodology, the total in-force policy count is up 4.28% from October 1, 2010 — an increase of 4.57% for non-fleet private passenger policies and a decrease of 3.84% for all other than private passenger policies.

With the transition to EDGE, we have made improvements in our management system that result in a more accurate report, which better reflects cancellation, reinstatement and withdrawal activity. However, in this process there could appear to be unusual variances for individual carriers in their in-force counts making year-to-year comparisons difficult between 2010 and 2011.
